Budgets and Final Accounting

Budgets for 2015

The COA and its affiliated agencies: The total budget for the COA and its affiliated agencies for the 2015 fiscal year was NT\$122.87 billion, an increase of NT\$1.21 billion (1%) over the 2014 figure of NT\$121.66 billion. Figures 1 and 2 show the allocations by function and by organization, respectively.

Figure 1 Budget allocations by function, 2015

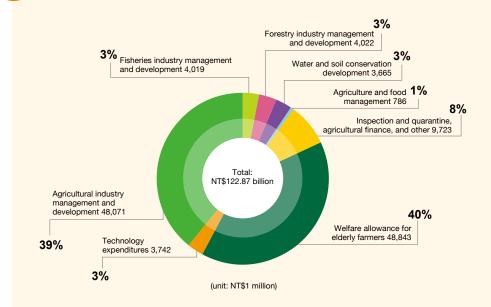
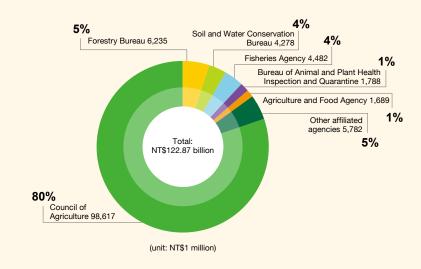
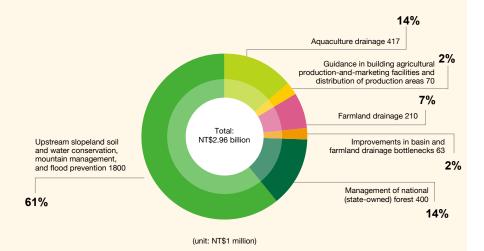

Budget allocations by agency, 2015



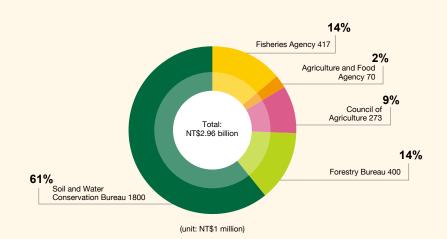
Budget for the first phase of the Plan for Integrated Management of River Basins, by function, 2015



Integrated management of river basins: The special budget for the first phase (2014-2015 fiscal years) of the Plan for Integrated Management of River Basins, for which the COA is the governing agency, totaled NT\$4.73 billion. The budget for the 2015 fiscal year was NT\$2.96 billion. Figures 3 and 4 show allocations of the first phase of this special budget by function and organization, respectively.

 - The total revenues were NT\$50.06 billion, versus NT\$48.56 billion in 2014, an increase of NT\$1.5 billion (3.1%).
 - The total expenditures were NT\$38.45 billion, versus NT\$38.81 billion in 2014, a decrease of NT\$360 million (0.9%).
 - The total balance was in surplus by NT\$11.61 billion. (See Figure 5)

Final Accounting for 2015

■ The COA and its affiliated agencies: In 2015, the total budget for the COA and its affiliated agencies was NT\$122.87 billion. In addition, NT\$210 million was mobilized from the Secondary Reserve Fund, making the actual available budget a total of NT\$123.08 billion. The final account was NT\$122.56 billion (including NT\$117.96 billion in actual expenditures, NT\$1.02 billion payable, and NT\$3.58 billion reserved). The surplus was NT\$520 million. Expenditures accounted for 99.58% of budgeted funds. A functional breakdown is presented in Figure 6.

Integrated management of river basins: The special budget for the first phase (2014-2015 fiscal years) of the Plan for Integrated Management of River Basins, for which the COA is the governing agency, totaled NT\$4.73 billion. The final accounting was NT\$4.6 billion (including NT\$3.53 in disbursed funds and NT\$1.07 billion in reserve). A functional breakdown is presented in Figure 7.



A comparison of the budget and the final accounting for subsidiary agencies, 2015



Subsidiary Agencies:
In the final accounting for 2015 for subsidiary agency expenditures, total revenues were NT\$51.92 billion, which was 103.7% of the budget (NT\$50.06 billion). Total expenditures were NT\$41.34 billion, which was 107.5% of the budget (NT\$38.45 billion). As a result, there was a surplus of NT\$10.58 billion. (See Figure 8)
